In the last newsletter, it was reported that the Chapter was the recipient of a \$3,500 mini grant administered through the Western Pennsylvania Conservancy and funded by Berkshire Hathaway Energy Gas Transmission and Storage (BHE-GT&E). This money will be used to help fund phase two of the Stewart Run project.

The awards ceremony and presentation was held on Wednesday, April 19 at Chestnut Ridge Conference Center in Blairsville. I accepted the award on behalf of the Chapter, and Phil Thomas gave a brief PowerPoint presentation outlining phase one and two of the project. Fifteen grants were awarded to various groups throughout western Pennsylvania.

Working with the contractor, Saturday, August 19 has been set for the workday and August 26 as an alternate. Please plan to attend if possible. Most of the work will be done by machinery, but we always welcome participation. The work site is located on State Game Lands #79. The parking lot where we will meet can be accessed off Route 22, 2.1 miles west of the 219 interchange. We will have the grill on site for a cookout

A stream habitat improvement field tour was held on June 1 at Prince Gallitzen State Park. This event was presented by Scott Koser, Phil Thomas, and J.J. Zielinski - all full-time T.U. staff working with Pennsylvania's coldwater habitat program. They assist with design work and finding and securing funding sources for similar projects.

There was a PowerPoint presentation followed by a walking tour of the completed work on near-by Killbuck Run, which drains into the lake. Phil and J.J. are both stream restoration specialists. The work had begun in 2017 and had just recently been completed. County conservation districts from Indiana, Cambria, Blair, and Bedford counties attended with 23 people present. Three M.L.T.U. representatives were the only non-professionals in attendance.

The walking tour was very informative; use of root wads, traditional deflectors, mudsills, diverters, and cross vanes were examined. Also, the importance of adding large wood to the streambed, floodplain, and side channels was examined and explained in detail.

The term "chop and drop" and how it works to hold back sediment and to trap leafy debris, as well as the benefits of this method, were explained. It was evident that the entire system was working as intended.

Additionally, Tim Yeager, Assistant Park Manager, gave a tour of the lake bank where sawtooth deflectors and stone has been positioned to illustrate efforts being made to eliminate erosion from wave effects on the lake itself.

Chapter members have had an active spring. Litter pick-ups occurred along:

- Bens Creek / Route 985
- Yellow Creek Gap / Route 36
- Higgins Run / Slagle Hill Road
- Little Paint Creek / Berwick Road & SR160, and
- Clear Shade Creek / Crumb Road.

All of the pick-ups were well attended with many new participants, so each of the sites were completed in just a few hours.

Under the radar, M.L.T.U. assisted with fish stockings on area streams and float-stocked the remote sections of Clear Shade and Little Mahoning Creeks.

Chapter members assisted with Trout in the Classroom Release Days with Blacklick Valley, Shanksville-Stonycreek, Shade-Central City, and Divine Mercy schools. Fly tying, fly rod casting, and macroinvertebrate sampling, along with many other activities and conservation groups were exposed to the students. A new generation introduced to the message of coldwater conservation!

We once again participated at the Windber Sportsman's Kids fishing rodeo where 199 kids registered. We demonstrated fly tying and had a sampling of macroinvertebrates and explained to the kids that you start with clean, cold water to support a food base of "bugs" that the fish then eat and then, as fly fishers, we tie flies that imitate the natural insects to fool and catch the fish.

For the Rodeo, we had collected a large crayfish which was very popular with the kids as they challenged each other to pick it up. Another boy "borrowed" our sculpin but, predictively, never returned it. Many parents and grandparents thanked us for being there. The Chapter has committed to participate in a similar event in the Turkeyfoot Valley area in mid-June.

Work days are being planned on Bens Creek, Stewart Run, Potter Creek, and Clear Shade Creek. We started staging the onsite materials for the projects.

Thank you to all that participated in each of these important activities.

Representatives of Blue Knob State Park, Gallitzin State Forest, MLTU, Penguin Court, Pennsylvania Fish and Boat Commission, Pennsylvania Master Naturalist, Prince Gallitzin State Park, Stonycreek-Conemaugh River Improvement Project, Shade Creek Watershed Association, Somerset Conservation District, and Western Pennsylvania Conservancy all made these days possible, as did the Greater Ferndale and Shade Sportsmen's Clubs, which let us use their grounds at no cost.

I have no doubts that students will remember "that time" they raised fish in a classroom!
